2. The petitioner was employed as Record Clerk in the respondent Society. He quit his service as early as on 30.04.2018. His grievance is that his retirement benefits have not been settled in full. Substantial amount still remains to be paid. The respondents 3 and 4 are directed to pay the balance amount to the petitioner within a period of four months from the date of receipt of a copy of this order. If within four months the balance amount is paid, it will not carry any interest. If within the stipulated time the balance amount is not paid to the petitioner, it will carry interest at the rate of 6% per annum from the date of the petitioner's original entitlement.
