ORDER

2.This writ petition has been filed for change of enquiry officer. The case of the writ petitioner is that the third respondent figured as witness in the criminal case against the writ petitioner herein and that such a person could not have been appointed as enquiry officer.

3.When the matter was taken up for hearing, the learned Additional Government Pleader submitted that an order appointing the third respondent as enquiry officer has since been changed. Copies of the
