The learned counsel appearing for the petitioner would submit that the petitioner has given a representation dated 09.03.2023 before the respondent for missing of his Doc.No.1812 of 1994 dated 07.06.1994 and Doc.No.3421 of 1997 dated 06.11.1997 registered at the office of the Sub-Registrar, Sivakasi, but no action was taken as on date and hence, he has also sent a representation to the respondents.

Considering the above, the respondent police is directed to conduct enquiry and complete the same by following the circular issued by the Director General of Police within a period of three months from the date of receipt of a copy of this order. Depending upon the outcome of the enquiry, the petitioner shall workout his remedy through appropriate proceedings.

6. With the above direction, this Writ Petition stands disposed of.
