PRAYER :- For Anticipatory Bail in Crime No.186 of 2023 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner/A2, who apprehends arrest at the hands of the respondent police for the offences punishable under section 25(1B)(a) of the ARMS Act, 1959 in Crime No.186 of 2023 on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution is that when the respondent police was in patrol duty, he seen in social media that the petitioner was teaching A2 and his relative how to operate a gun. Hence, the complaint.
