According to the fifth respondent, what remains to be paid to the petitioner is only Rs.2,70,156/-. In exercise of writ jurisdiction, this Court may not be able to workout the correct figure. I will therefore go by the admitted position of the fifth respondent. The fifth respondent shall pay the admitted
