This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus to directing the 2nd Respondent to grant permission and necessary protection to perform the cultural program (ie.,) Adal Padal on 13.04.2023 at 07.00 PM to 10.00 PM in the evening of “Arulmigu Sri Muthumariamman Thirukovil Thiruvizha”, Melur, Madurai District consider the petitioner's representation dated 28.03.2023.

2. Mr.S.Manikandan, learned Government Advocate (Crl. Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that festival for the temple, by name, “Arulmigu Sri Muthumariamman Thirukovil Thiruvizha”, Melur, Madurai District is going to be held on 13.04.2023. Subsequent to the same, in order to conduct a cultural programme on 13.04.2023 at 7.00 PM to 10.00 PM they sought permission of the police by giving a representation dated 28.03.2023. But, the respondent has not considered the said representation. Since no order was passed, the writ petitioner has come before this Court for the

above said relief.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc. 007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the 2nd respondent is hereby directed to consider the representation of the writ petitioner, dated 28.03.2023 and pass suitable orders based on the above said circular.
