PETITION FOR BAIL Under Sec.439 of Cr.P.C.

PRAYER :-

For Bail in Crime No.224/2022 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner/A3, who was arrested and remanded to judicial custody on 28.07.2022 for the offences punishable under Sections 8 (c) r/w 20(b)(II)(C) and Section 25 of NDPS Act, 1985, in Crime No.224 of 2022 on the file of the respondent police, seek bail.

2. The case of the prosecution is that on 28.07.2022 at about 01.00 p.m., on secret information, the respondent police went to the place of occurrence. On seeing the police party, A1 to A4 tried to run away from the place of occurrence. But the respondent police nabbed the accused and they were found in possession of 34kgs of Ganja. Hence, the case.

3. Heard. Perused the materials available on record including the First Information Report.

4. This is the third application for bail and the earlier two applications for bail in CrI.O.P.(MD)No.16650 of 2022 was dismissed by this Court on 03.11.2022 and CrI.O.P(MD)No.22944 of 2022 was



dismissed as withdrawn by this Court on 21.02.2023 and the change in circumstances of the case to consider the present bail petition even after dismissal of the petitions. Hence, this court is not inclined to grant bail to the petitioner.

5. Accordingly, the petition stands dismissed.
