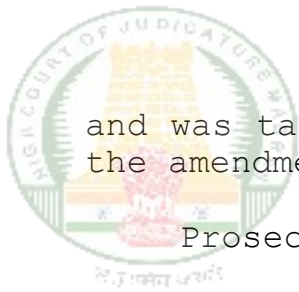
Prayer in CRL OP(MD). 8305/ 2021 :
