2.The learned counsel for the petitioner has submitted that without going into the merits of the case, time frame may be given for disposal of the appeal in A.S.No.25 of 2018 on the file of the Subordinate Court, Tiruchendur, and till the disposal of the appeal, *status quo* may be ordered.
