ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents to grant permission and necessary protection to conduct the “Adal Padal” Programme on 30.04.2023 at 07.00 pm to 12.00 pm in connection with “Thiruvizha” of Arulmigu Sri Parasakthi Mariamman Thirukovil at Elayirampennai, Vembakkottai Taluk, Virudhunagar District.

2. Mr.S.Manikandan, learned Government Advocate (Crl. Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that festival for the temple, by name, Arulmigu Sri Parasakthi Mariamman Thirukovil at Elayirampennai, Vembakkottai Taluk, Virudhunagar District.. is going to be held on 30.04.2023. Subsequent to the same, in order to conduct a cultural programme on 30.04.2023 at about 07.00 pm to 12.00 am they sought permission of the police by giving a representation dated 15.03.2023. But, the respondent has not considered the said representation. Since no order was passed, the writ

petitioner has come before this Court for the above said relief.

Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents are hereby directed to consider the representation of the writ petitioner, dated 15.03.2023 and pass suitable orders based on the above said circular.
