This Criminal Original Petition has been filed to direct the 2nd Respondent not to harass the petitioners in the name of enquiry in the alleged compliant given by the 3rd and 4th Respondents.

2.The learned Additional Public Prosecutor would submit that on the basis of the complaint given by the respondent enquiry was undertaken in C.P.No.697 of 2022. During the course of enquiry it was found that it is the issue between the parties over drawing of water from the common Well.
