3.The learned counsel for the petitioner would submit that absolutely, there is no involvement by the petitioner. Compulsion has been made by the second respondent to admit the above said commission of offence.

4.When serious allegation is made it is the duty of the respondent to investigate the matter. There is no question of harassment. The
