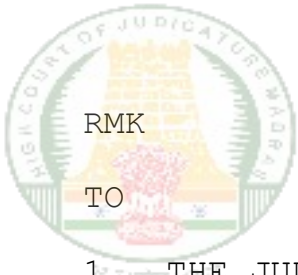
4.Accordingly, this Criminal Miscellaneous Petition is allowed.
