2.The learned counsel for the petitioner would submit that since the petitioner is a coolie, he is not able to deposit a sum of Rs.25,000/- as imposed by this Court.

3.Considering the said facts and circumstances of the case, the condition already imposed on the petitioner in condition No.7(b) in Crl.O.P.(MD)No.4621 of 2023, dated 13.03.2023 is deleted. All other



conditions in the said order dated 13.03.2023 shall be unaltered.

4. Accordingly, the Criminal Miscellaneous Petition is allowed.
