Prayer in Crl.A(MD) No.161 of 2023 :-

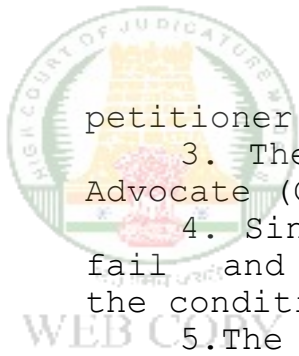
