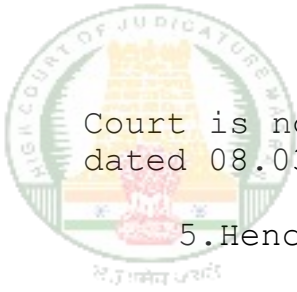

This Criminal Miscellaneous Petition has been filed to modify the surrender Court as to learned Judicial Magistrate, Gandarvakottai and Gandarvakottai Police Station instead of the learned Judicial Magistrate No.III, Trichy and Manachanallur Police Station in order dated 08.03.2023 in Crl.O.P.(MD)No.2341 of 2022.
