Prayer :- This Civil Miscellaneous Petition filed under Section 173 of Motor Vehicle Act to set aside the award passed by the Motor Accident Claims Tribunal, Principal District Judge, Pudukkottai in MCOP.No.379 of 2020 dated 05.10.2021.

ii)that the claimants be and hereby are permitted to withdraw above said amount as per the apportionment made by the Tribunal; and

iii)that there be no order as to costs in this Civil Miscellaneous Appeal.
