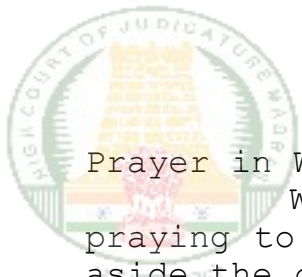

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the Respondents 1 to 5 herein to regularize the service of the Petitioner as Full Time Sanitary Worker (Sweeper) on completion of 10 years of Part Time Services from 01.04.1981 and to pay time scale of pay and other monetary benefits payable from 01.04.1991 along with arrears within a stipulated time as fixed by this Honble Court.
