2. On the basis of the compromise reached between the parties, the co-accused, namely, 1 to 3 have filed CrI.O.P(MD).No.16490 of 2021 before this Court to quash proceedings in C.C.No.243 of 2019 pending on the file of the learned Judicial Magistrate No.II, Kuzhithurai. This Court by the order dated 11.03.2023, quashed Charge sheet against the accused namely 1 to 3.

3. The learned counsel for the petitioner submitted that the benefit of the above said order can be extended to this petitioner also, since this petitioner is also standing on the same footing, on that ground, this petition can be allowed.
