2.The petitioner is the accused person in Crime No.101 of 2023 on the file of the respondent police for the offences punishable under Sections 294(b), 323 IPC and 3(1)(r), 3(1) (s) and 3(2)(va) of the Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

3.Mr.B. Nambiselvan, learned Additional Public Prosecutor accepts notice for the respondent. He submitted that no previous case is pending against the petitioner and the injured person has been discharged from the hospital.

4.Considering the facts and circumstances of the case, this Court is inclined to pass the following orders :-

1) The petitioner shall appear before the I Additional District and Sessions Court (PCR Court), Thanjavur under the SC/ST Act within a period of 15 days from the date of receipt of a copy of this order.

2) On such surrender along with notice served to the defacto complainant, the concerned Judge shall consider the bail application filed by the petitioner and pass orders on merits on the same day of her surrender, after hearing the defacto complainant by complying with Section 15A(5) of the Act.

5. With the above observation, this Criminal Original Petition is disposed of.
