This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus directing the respondents to grant permission and necessary protection to conduct the “Adal Padal” programme on 25.04.2023 at 6.00 pm to 11.00 pm in connection with “Thiruvizha” of Arulmigu Sri Mariamman Thirukoil at Nanaparappu Village, Pugalur Taluk, Karur District.

2. Mr.R. Sureshkumar, learned Government Advocate (Crl. Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner submitted that festival for the temple, by name, AArulmigu Sri Mariamman Thirukoil at Nanaparappu Village, Pugalur Taluk, Karur District is going to be held on 25.04.2023. Subsequent to the same, in order to conduct a cultural programme on 25.04.2023 at 6.00 pm to 11.00 pm, they sought permission of the police by giving a representation, dated 25.03.2023. But, the respondents have not considered the said representation. Since no order was passed, the writ petitioner has come before this Court for

the above said relief.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc. 007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the respondents are hereby directed to consider the representation of the writ petitioner, dated 25.03.2023 and pass suitable orders based on the above said circular.
