“For the reasons stated in the accompanying affidavit, it is most respectfully prayed that this Hon'ble Court may be pleased to issue Writ of Mandamus or any other order or direction in the nature of writ, forbearing the Respondents 2 to 7 from evicting the Petitioners from their patta land in plot Nos.60 and 41 in Survey No.181/2B and 188/5 and it is sub-division situated at Perungudi Village, Madurai South Taluk, Madurai District without following the due process of law by considering the petitioners common representation dated 05.04.2023 within the time stipulated by the Hon'ble Court and pass any further or other order as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render Justice.”
