Learned Government Pleader appearing for the respondent has produced a copy of the application, dated 05.04.2023, given by the petitioner to the respondent seeking permission to conduct Orchestra on 16.04.2023 at 06.00 p.m. However, on the reverse of the said application itself, the petitioner has undertaken that he will complete the celebration before 02.00 p.m., on 16.04.2023 and he will not conduct the Orchestra programme.

4. In view of the same, the writ petition is dismissed. No costs.
