Prayer in CMP(MD). 4182/ 2020 :

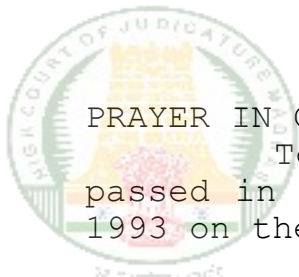
