Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.MANIYARASU.K.C, Advocate for the petitioner and of Mr.B.THANGA ARAVINDH, Government Advocate(crl.side) on behalf of the Respondent, the court made the following order:-

This Criminal Miscellaneous Petition has been filed to modify the condition in Condition No.5(a) imposed on the petitioner in Crl.O.P.(MD)No.4530 of 2023, dated 09.03.2023.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent.

3.Considering the facts and circumstances of the case, the condition already imposed on the petitioner is modified to the effect that **"the petitioner shall pay a sum of Rs.10,000/- (Rupees**



Ten Thousand only) to the credit of FIR in Crime No.48 of [redacted] at the time of furnishing sureties", instead of the petitioner shall pay a sum of Rs.15,000/- directly to the defacto complainant as compensation and on production of proof/acknowledgement the learned Magistrate shall accept the sureties furnished by the petitioner.
