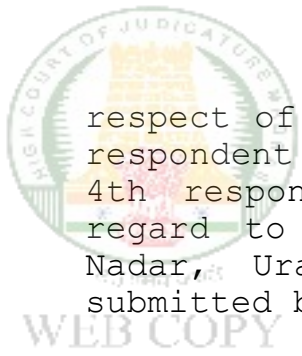

Prayer in Sub A(MD)No.129 of 2023 :- Sub Application filed under Section 151 of C.P.C., to restore the contempt petition filed in Cont.P.(MD)No.557 of 2023 dated 05.04.2023.

Prayer in Cont.P(MD)No.557 of 2023:- Contempt Petition filed under Section 11 of the Contempt of Courts Act, 1971 against the Contemnors/respondents herein for their willful disobedience to the order passed by this Hon'ble Court in WP(MD)No.16120 of 2020 dated 26.04.2021.

Prayer in WP(MD)No.16120 of 2020 :- Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a writ of Certiorarified Mandamus, call for the records in



respect of the impugned Form-VII dated 23.05.2020 passed by the respondent and quash the same as illegal and consequently direct the 4th respondent not to accord approval for the application with regard to transfer of management effected in T.N.Pudukudi Hindu Nadar, Uravinmurai Higher Secondary School based on proposals submitted by 7th respondent.

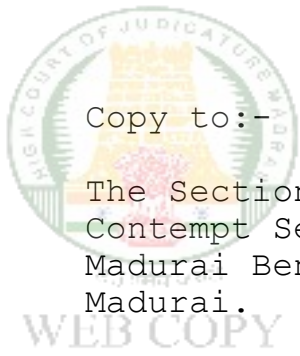
