PETITION FOR BAIL Under Sec.439 of Cr.P.C.

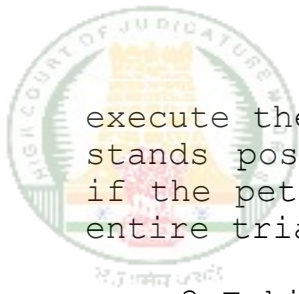
PRAYER :-

For Bail in Crime No. 118 of 2013 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/All herein was arrested and remanded to judicial custody on 04.01.2023 for the alleged offence under Sections 120(B), 147,148,341,302 r/w.149 of IPC in Crime No.118 of 2023 on the file of the respondent police seeks bail.

2. Originally the petitioner was granted bail in Crime No.118 of 2013. The respondent after completion of investigation filed final report and the same was taken on file in S.C. No. 22 of 2023 and pending on the file of the learned III Additional Sessions Judge, Tirunelveli, however the petitioner failed to appear before the trial Court on 11.11.2021, as such Non Bailable Warrant was issued against him. While pending Non Bailable Warrant he involved in so many cases and he was arrested and remanded to judicial custody. He was produced on P.T warrant in this case in order to



execute the Non Bailable Warrant issued as against him. Now the stands posted for examination of L.W. 1 to L.W.3 and at this stage if the petitioner is released on bail, he may abscond again and the entire trial will be stalled

3. Taking into consideration all the above facts and also the fact that the petitioner involved in 23 previous cases, this Court is not inclined to grant bail to the petitioner.

4. In the result, the petition stands dismissed.
