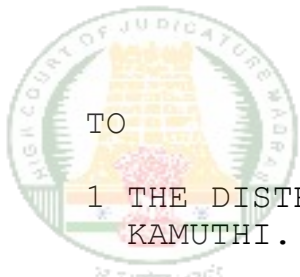
This petition is ordered. The absence of the petitioner before the respondent police is hereby condoned.
