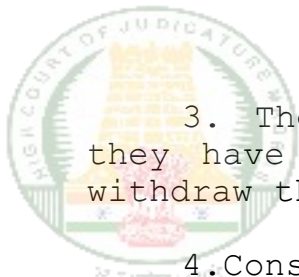
Prayer in CRL RC(MD). 320/ 2023 :
