This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant MR.C.JAWAHAR RAVINDRAN and the counsel for the respondents MR.L.M.VIJAI BOOMINATHAN are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.



AWARD

Both sides present. As per the settlement arrived in the Lok Adalat, both parties have agreed to settle the amount of **Rs.14,50,000/- (Rupees Fourteen Lakhs and Fifty Thousand only)** with interest at the rate of **7.5% from the date of petition till the date of deposit.** The appellant/Insurance Company is directed to deposit the entire award amount, less the amount already deposited, if any, within a period of **4 weeks** from the date of receipt of a copy of this order. On such deposit, the claimants/respondents 1 and 2 are permitted to withdraw their share amount without filing formal petition before the Tribunal.
