The above writ petition is filed to call for the records relating to the impugned proceedings of the third respondent/Director of School Education in R.C.No.0012/PA/JDS/2018 dated .09.2018 and the consequential proceedings in R.C.No.001027/FC/2020, dated 25.06.2020, quash the same.

2. It was brought to the notice of the Court that pending this writ petition, the Government had given powers to Correspondent/Secretary of the Schools to exercise the powers to operate the Integrated Financial and Human Resource Management System (IFHRMS), vide order dated 30.11.2021. This was reiterated by the Joint Director, Chennai, vide his proceedings dated 07.04.2022 in Na.Ka.No.008455/D-1-E4/2019. On the basis of these orders, W.P(MD)No.33092 of 2018 and W.P.(MD) No. 7448 of 2020 were disposed of.
