3. The petitioner's request for conducting the cultural programme has not been acted upon by the respondent police, which prompted the petitioner to file the present writ petition.

4. When the matter is taken up for hearing, the learned Government Advocate (Crl. Side) would submit that the representation given by the petitioner will be considered by the second respondent within a short period.
