PRAYER IN CRL A(MD) Nos.71 of 2023:-

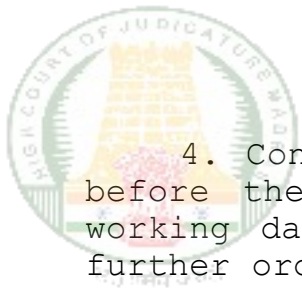
