CRL A(MD)No.150 of 2023:

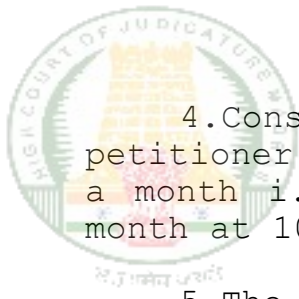
