2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents.

The learned counsel appearing for the petitioner would submit that the petitioner has lodged a complaint before the second respondent for misplacing of his original sale deed document bearing No.2104/2008, dated 23.04.2008 and document bearing No.2105/2008, dated 23.04.2008, which were situated at Tiruthangal Village, Sivakasi Taluk, Virudhunagar District. He would further submit that the petitioner has also made paper publication on 25.03.2023 with regard to the missing of original document.

4. Considering the above, the second respondent police is directed to conduct enquiry ensuring the said document has not been deposited for any purpose, following the circular issued by the Director
