2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents.

The learned counsel appearing for the petitioner would submit that the petitioner has lodged a complaint on 11.04.2023 through registered post before the respondents for misplacing of his original sale deed document bearing No.613 of 2020 dated 11.04.1960. The property is situated at Pasumpon Village, Kamuthi Taluk, Ramanathapuram District. He would further submit that the petitioner has also made paper publication on 28.03.2023 with regard to the missing of original document.

4. Considering the above, the second respondent police is directed to conduct enquiry ensuring that the said document has not been deposited for any purpose, following the circular issued by the Director
