Prayer CRL MP(MD) . No.7052 of 2023:-

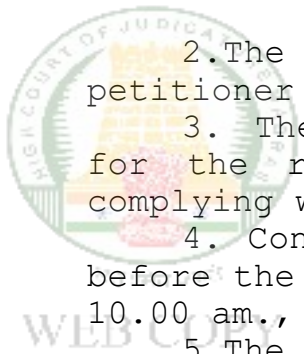
