If any discrimination or objection is made by any party, the petitioner or any affected persons have a right to give a complaint to the fourth respondent/Tahsildar, Sivagangai Taluk, Sivagangai District and the fifth respondent/Inspector of Police, Sivagangai Taluk Police Station, Sivagangai District. A specific direction is issued to the aforementioned two officials to immediately take on record the complaints. That apart, also to conduct an enquiry into the same and enunciate that equality in worshipping before the said temple is upheld by everybody. This would apply not only to day to day worship but specifically to every special festival conducted in the said temple.

4. With the above observations and directions, this Writ Petition stands disposed of. No costs. Consequently, connected miscellaneous petitions is closed.
