The Writ Petition has been filed in the nature of a Mandamus seeking a direction to the respondents 1 and 2 / Tahsildar, Taluk Office, Kokkirakulam Palayamkottai, Tirunelveli, and the Taluk Surveyor in the same office, to conduct survey with respect to the lands in Survey No.197/14 at Ponnakudi Village, Palayamkottai Taluk, Tirunelveli District. The petitioner had given an application on 30.11.2022 and 30.01.2023.

3. The petitioner had also paid the necessary charges on 02.12.2022. The petitioner had also impleaded as the respondents 4 to 6, the adjacent land owners. However, patta stands in the name of the petitioner herein.

4. A direction is given to the respondents 1 and 2 to issue notice to the respondents 4 to 6 who are the adjacent land owners and in their presence, proceed to conduct survey of the aforementioned lands. If required, the respondents 1 and 2 may also seek the assistance of the third respondent the Jurisdictional Inspector of Police. At any rate, the

entire exercise must be completed within a period of twelve (12) weeks from the date of receipt of a copy of this order.
