This Criminal Miscellaneous Petition has been filed to modify the condition imposed against the petitioners in Crl.O.P(MD).No.6051 of 2023 dated 31.03.2023 on the file of this Court related to execute a bond for a sum of Rs. 10,000/- with two blood related sureties.

2.Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Crl.side) appearing for the respondent.

3.Considering the facts and circumstances of the case, the condition already imposed on the petitioner relating to execute a bond for a sum of Rs. 10,000/- with two blood related sureties **is** ~~modified~~ to the effect that "the petitioner shall execute a bond



for a sum of Rs.10,000/- (Rupees Ten Thousand only) to sureties, each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed."
