ORDER

2. The petitioner had given a representation on 19.04.2023 and she had paid necessary charges. The petitioner stated that she is in possession of the said land and patta had also been granted to her. She had purchased the land by Document No.6886/2020 dated 16.10.2020.

3. In view of the above facts stated, a direction is issued to the respondents herein to proceed further to conduct survey of the land in accordance with the representation given by the petitioner herein. The
