Prayer in CRL RC(MD). 160/ 2023 :

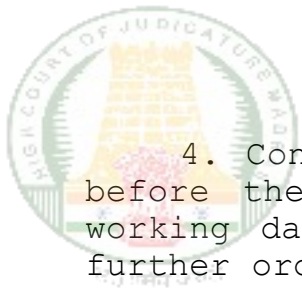
