ORDER

This Criminal Original Petition has been filed to direct the second respondent or his subordinates not to harass or ill-treat the petitioner and her family members under the guise of enquiry in connection with a civil dispute at the instance of respondents No.3 to 6.

2. The learned Additional Public Prosecutor would submit that on the basis of the complaint given by the sixth respondent, enquiry was undertaken. During the course of enquiry, it was found that it is a issue between the daughter-in-law and mother-in-law, over the occupation of property. Based on the above said enquiry, the parties were advised to workout their remedy through the civil process. On 13.04.2023, the husband of the petitioner appeared before the Circle Inspector, Elumalai, and had given an undertaking that they will resolve their issue among themselves in the presence of elders. On the basis of the above said undertaking and advice, the above said complaint was closed on 26.11.2023.
