For Bail in Crime No.113 of 2022 on the file of the Respondent Police.

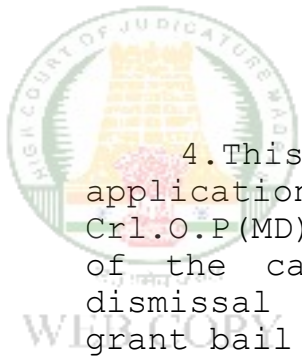
ORDER : The Court made the following order :-

The petitioner /A3 who was arrested and remanded to judicial custody on 05.04.2022 for the offences under sections 8(c) r/w.20(b) (ii) (C) of NDPS Act seeks bail.

2.The case of the prosecution is that on 05.04.2022, based on the secret information, the respondent police along with police party went to scene of occurrence Potthur near Anna Arch and found that the petitioner and other accused were found in possession of 22 kg of Ganja. Hence, the case has been registered.
