The Superintendent of Police*, in *W.P.(MD) No.2095 of 2023*, the District Collector, Thanjavur, is directed to consider the application of the petitioner dated 15.04.2023, well in advance and grant permission for conducting 'Bullock and Horse Cart Race' on 07.05.2023 at Thirupooranikadu bus stop, Peravurani, Thanjavur District, between 6.00 a.m. and 09.00 a.m., subject to the other usual conditions.

5. The writ petition is disposed of with the above direction. No costs.
