ORDER

The Writ Petition has been filed in the nature of a Mandamus seeking a direction to the respondents 2 and 3, to conduct survey of the land of the petitioner in Survey No.128/5B measuring 0.0700 Hectares at Alangulam Group, Keelakarai Taluk, Ramanathapuram District.

The aforementioned lands were originally assigned to the father of the petitioner, Muniyandi and later changed to the name of the petitioner and his two brothers namely, Kalaivallal and Manoharan, by proceedings of the Zonal Deputy Tahsildar, Ramanathapuram, dated 13.04.1997. The petitioner seeks to rebuild the house, since it is
