2.It is further stated that the fifth respondent had obtained patta in his name. Questioning that particular fact, the petitioner herein had filed an application before the third respondent/Revenue Divisional Officer, Kovilpatti, Thoothukudi District and the same was ordered in her favour. Thereafter, the fifth respondent had filed an appeal, which is pending before the second respondent/District Revenue Officer, Thoothukudi.
