ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, directing the respondents to grant permission and adequate police protection for conducting Kabadi Tournament at Ambedkar Thidal, Perur, Musiri Taluk, Trichy District, dated 29.04.2023 at 08.00 p.m to 30.04.2023 at 10.00 p.m., based on my representation dated 20.04.2023 to submitted in person to the third respondent.

2. Mr.R.Suresh Kumar, learned Government Advocate(Crl. Side) takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned counsel appearing for the writ petitioner would submit that in order to conduct kabadi tournament at Ambedkar Thidal, Perur, Musiri Taluk, Trichy District, dated 29.04.2023 at 08.00 p.m to 30.04.2023 at 10.00 p.m., they sought permission of the police by giving a representation dated 20.04.2023. But, the respondents have not considered the said representation. Since no order was passed, the writ petitioner has come before this Court for the above said relief.

4. The learned Government Advocate(Crl. Side) Prosecutor appearing for the respondents would submit that the respondents have received the representation of the writ petitioner and the same is pending for consideration.

5. I have considered the submission of the learned counsel appearing for the writ petitioner and the learned Government Advocate(Crl. Side) appearing for the respondents.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the third respondent is hereby directed to consider the representation of the writ petitioner dated 20.04.2023 positively and pass orders imposing necessary conditions based on the above said circular.
