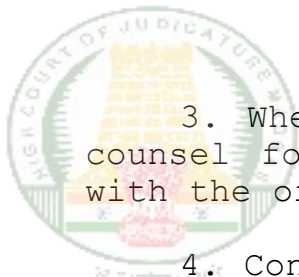
Prayer in CRL MP(MD). 2205/ 2023 :

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.MOHAMED MOHIDEEN T.S., Advocate for the petitioner and of MR.A.MOHAMED HANEEF, Advocate on behalf of the Respondent, the court made the following order:-

This petition has been filed to extend the time to pay the entire arrear amount made in Crl.M.P.(MD)No.2205 of 2023 in Crl.R.C (MD)No.154 of 2023, dated 27.03.2023.

2. When the matter was taken up for hearing on 27.03.2023, this Court directed the petitioner to pay the entire arrear amount of maintenance pending at that time to the respondent on or before 24.04.2023 and that subsequently, time was extended twice and lastly till 14.06.2023.
