2. The learned counsel for the petitioner would submit that the petitioner worked in the 2nd respondent Society and retired from service. He was sanctioned with the monthly reduced pension under pension payment order. His contribution under the EPF scheme, was remitted on wage ceiling, however, not on actual wages. It is his case that the Apex Court has directed the Regional Provident Fund Commissioner to permit the members to seek the return of all amounts that the employees may have taken or withdrawn before granting the benefit of the proviso to clause 11(3) of the Pension Scheme. Accordingly, it is the case of the petitioner as per the direction of the Apex Court, the petitioner is entitled for revised pension and hence, prays for appropriate direction.

3. The learned counsel for the respondents would submit that after disposal of the Special Leave Petitions by the Apex Court, the respondents are calculating to disburse the amount in favour of the employees and the entire amount will be disbursed in favour of the employees in terms of the order passed in the SLPs by the Apex Court within a period of four weeks.
